WHEREAS, the SOUTH SNOHOMISH COUNTY FIRE & RFA (the "Authority") must, pursuant to RCW 42.56.580, appoint a public records officer whose responsibility is to serve as a point of contact for members of the public in requesting disclosure of public records and to oversee the agency's compliance with the public records disclosure requirements of the Public Records Act, Chapter 42.56 RCW.

NOW, THEREFORE, BE IT HEREBY RESOLVED as follows:

- 1. The Governing Board of Commissioners of the Authority appoints Amy Nay as the Public Records Officer for the Authority.
- 2. In the absence of the appointed Public Records Officer, the Fire Chief shall designate an acting Public Records Officer.
- 3. The name and contact information of the Public Records Officer shall be published in a way reasonably calculated to provide notice to the public, including posting at the Authority's place of business, posting on its internet site, or including in its publications.
