## 2024 Approved Central Monitoring Stations

**Updated May 2024** 

The following is a list of companies that have met South County Fire Prevention standards for an approved Central Monitoring Station (CMS). South County Fire has a proactive approach to fire prevention and values balancing the investments of the business community, the expectations of the citizens and visitors, and the applicable codes and standards. We believe that prevention is preferable to response and is a key guiding principle.

The currently adopted International Building and Fire Codes, NFPA, Washington State law, local ordinances, other applicable standards/laws, and administrative interpretations by the Fire Marshal, govern the way in which fire protection is accomplished in South County Fire Prevention's jurisdiction. The CMS is a vital part of the fire protection system. In concert with construction methods, monitored fire protection systems provide early detection and response, minimizing life hazards and building loss.

These companies comply with South County Fire's current Fire Alarm Requirements, have provided a copy of the current UL 827/FM 3011 certificate of compliance for each CMS location and a copy of the written procedure for communicating with the CMS, have current business licenses, and have agreed to report all alarm, supervisory, and trouble signals still unrestored after 24 hours, and disconnection notices to the South County Fire Prevention. If you are currently using a central monitoring station not on this list, they are not approved.
