## SECOND AMENDMENT TO INTERLOCAL AGREEMENT FOR FIRE AND EMERGENCY MEDICAL SERVICES

THIS SECOND AMENDMENT TO INTERLOCAL AGREEMENT FOR FIRE AND EMERGENCY MEDICAL SERVICES is entered into this \_\_\_\_\_3 day of February, 2015 between SNOHOMISH COUNTY FIRE PROTECTION DISTRICT NO. 1, a Washington municipal corporation (the "District") and the CITY OF BRIER, a Washington city (the "City") is for the provision of fire and emergency medical services.

**WHEREAS**, the District and the City are parties to an Interlocal Agreement for Fire and Emergency Medical Services ("Agreement") dated January 13, 2005; and

**WHEREAS**, paragraph 4.1.3(f) of the Agreement provides for the City to make a retroactive payment to the District if the District does not settle its labor agreement with IAFF Local 1828 by December 1; and

WHEREAS, in 2014, the District settled its collective bargaining agreement ("CBA") with Local 1828 (the "Union") covering the period of January 1, 2013 – December 31, 2014; and

**WHEREAS**, on August 11, 2014, the District issued an invoice ("Retro Pay Invoice") to the City in the amount of \$256,240 for the 2013 and 2014 retroactive adjustment due to settlement of the CBA; and

**WHEREAS**, in light of certain discussions between the parties on several issues, including the level of fire marshal and public education services provided by the District during 2013 and 2014, the parties have agreed to the following terms and conditions:

NOW, THEREFORE, the parties agree as follows:

- 1. The District hereby issues a one- time adjustment to the Retro Pay Invoice in the amount of \$10,914.81. A revised invoice in the amount of \$245,325.19, attached hereto as Exhibit A, represents the revised retroactive payment obligation for the City under Article 4.1.3(f) of the Agreement (the "Retro Obligation") for the years 2013 and 2014.
- 2. The District hereby acknowledges receipt of a check from the City on January 21, 2015 for the full amount of the Retro Obligation. The District therefore considers the Retro Pay Invoice paid in full.
